

VILLAGE OF CORRALES

ORDINANCE NO. 17-006

AN ORDINANCE RELATING TO EMPLOYMENT STATUS OF VILLAGE EMPLOYEES; REPEALING THE "SPECIAL CLASSIFIED" STATUS FORMERLY OFFERED TO CERTAIN NEW EMPLOYEES AS REFLECTED IN SUBSECTIONS 28-92(4) AND 28-92(5) OF THE CODE OF ORDINANCES OF THE VILLAGE.

WHEREAS, the Village of Corrales (the "Village") has in the past hired certain full-time employees in a "special classified" status under which such employees were offered an increased pay scale but were not eligible for certain benefits normally associated with employment by the Village; and

WHEREAS, the Village Council, the governing body of the Village ("Governing Body") has been informed that there are no longer a significant number of employees in special classified status, and that the administration does not intend to hire new employees into such status in the future; and

WHEREAS, the Governing Body therefore finds that the continuation of the special classified employee status as reflected in Subsections 28-92(4) and 28-92(5) of the Village Code, being part of Ordinance No. 251, adopted March 3, 1993, as amended by Ordinance No. 339, adopted August 14, 2001, is unnecessary and should be repealed.

NOW, THEREFORE, BE IT ORDAINED by the Governing Body of the Village of Corrales, New Mexico, that

- 1. Subsections 28-92(4) and 28-92(5) of the Code of Ordinances of the Village (the "Code"), being parts of Ordinance No. 251, adopted March 9, 1993, as amended by Ordinance No. 339, adopted August 14, 2001, are **REPEALED**.
- 2. The adoption of this Ordinance shall not be deemed to affect or modify the employment status of any person who is an employee of the Village of Corrales on the date of adoption hereof.

SEVERABILITY CLAUSE: Should any section, paragraph, clause or provision of this Ordinance be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance. The Governing Body of the Village of Corrales hereby declares that it would have passed this Ordinance and each section, subsection, sentence, clause, word or phrase thereof irrespective of any one or more sections, subsections, sentences, clauses, words or phrases being declared unconstitutional or otherwise invalid.

<u>COMPILING CLAUSE</u>: This Ordinance shall be incorporated in and compiled as a part of the Code of Ordinances of the Village of Corrales, as provided herein.

<u>EFFECTIVE DATE AND PUBLICATION</u>: This Ordinance shall become effective and be in full force and effect from and after its passage, publication and posting, according to law.
